WHAT TO FLUSH DOWN THE TOILET



f you're wondering whether you can flush something down the toilet, use the 3 P's (Pee, Poop and Paper) as a rule of thumb. By practicing this rule, you will be helping ETWD avoid maintenance problems associated with the buildup of non-dispersible paper and tissue products (i.e. flushable wipes, baby wipes, facial wipes) that are routinely flushed down household toilets.

Wipes are generally produced using a woven process and do not disintegrate quickly when wet—as toilet paper does—even though the product may say "flushable". Once flushed, wipes tend to string together forming large balls of material that become lodged in wastewater pipes, the impellers of wastewater pumps and other wastewater process equipment.

For ETWD and many other agencies, this has become an ongoing maintenance problem that requires significant manpower to de-rag pumping equipment, bar screens and sewer clean-outs. According to Bloomberg, this problem is so severe that New York City pays \$19 million a year to keep fatbergs—sewage blockages mostly from wipes—from forming.

So remember to stick to the 3 P's rule and refrain from putting flushable wipes down the drain. You will save the District and our customers costly repairs and maintenance in the future!

IN THE NEWS - WATER QUALITY AND PFOA / PFOS

ou may have read a recent news story regarding PFOA / PFOS in the Southern California water supplies. This information addressed water quality that was specific to groundwater wells in north Orange County. The good news is that El Toro Water District and the water supply our customers enjoy are *unaffected* by the family of chemicals referred to as PFOA / PFOS. It's important for you to know that your water is safe to drink.

Even though there are no impacts from PFOA / PFOS in ETWD's water supply, the District wanted to share some updated and accurate information on this important topic because of the news coverage and public announcements from other water agencies.

PFAs are manmade chemicals prevalent in the environment and were once commonly used in many consumer products including carpets, clothing, furniture fabrics, paper food packaging, water/stain/grease resistant materials and fire-fighting foam used at airfields. These chemicals can be found in groundwater, affecting agencies in Orange County. This includes Orange County Water District (which manages groundwater resources in Orange County) and other north county cities and water districts such as the city of Anaheim and Yorba Linda. Because El Toro Water District does not rely on groundwater resources and instead obtains water exclusively through imported sources, the District's water supply is unaffected by PFOA / PFOS.

Treatment options are being researched but are likely to involve costly retrofits. This cost will likely need to be passed on to water customers of affected agencies. In some cases, agencies have shifted to alternative water supplies such as imported water while solutions are being developed. In addition, state regulators (including the California State Water Resources Control Board's Division of Drinking Water) serve as the lead policymakers addressing PFAS and are developing updated standards and guidelines. The District will inform our customers of any changes affecting El Toro Water District.
