
DROUGHT PERSISTS THROUGHOUT CALIFORNIA

The majority of California is facing an extreme drought. As dry conditions persist, conservation efforts are falling short of state targets. Although fall storms drenched Northern California with record-breaking rains, the state's water supply didn't receive enough of a boost to bust the drought. In fact, many of California's largest reservoirs are still holding less water than the historic level for this time of year.

In response, the District is updating our Water Shortage Contingency Plan and will evaluate whether to activate the plan to address potential water supply shortage conditions. Through the years, the District has invested in developing a diverse water portfolio to meet our customers' needs. However, it is crucial that we all work together to save water today and into the future.

How You Can Help

In light of California's emergency drought declaration and the Governor's call to reduce water use echoed by our wholesale water suppliers, the District is asking all customers to voluntarily reduce their water use by 15%.



SAVE WATER 365



- Water your lawn early in the morning or late in the evening to minimize evaporation.
- Watering your lawn is prohibited during and 48 hours after a measurable rainfall of at least 1/4" of rain.
- Choose water-wise plants and water efficient irrigation equipment.
- Adjust sprinklers to eliminate excessive runoff onto the sidewalk, driveway, street or gutter.

- Find and fix irrigation and household leaks as soon as possible.
- Sweep instead of hosing down hard or paved surfaces, such as sidewalks, driveways and patios.

Bright orange, yellow and red flowers bloom in the spring





WIPES CLOG PIPES

Did you know that wipes labeled "flushable" and "disposable" are not really flushable at all? These products can clog your pipes and cause sewer system backups and spills that can damage your home and our environment.

The good news is that, starting in July 2022, a new California law will require manufacturers of all wet wipes products, including diaper wipes, cosmetic wipes and surface cleaning wipes, to include on-package "Do Not Flush" warnings and the universal Do Not Flush symbol (shown here). The new labeling rules will help consumers make informed choices to protect their property and our communities.
