El Toro Regional Reservoir Floating Cover and Liner Replacement Project

The El Toro Regional Reservoir, known as the R-6 Reservoir, provides 275 million gallons of water storage. ETWD owns and operates the reservoir, which provides water and emergency water storage for ETWD. The reservoir also provides emergency water storage for Santa Margarita Water District and Moulton Niguel Water District. The reservoir was originally built in 1964 and was expanded in 2001 to meet daily peak demands and provide seasonal and emergency water storage to our south Orange County communities.

New cover and liner

The reservoir's current liner and cover are made of reinforced polypropylene installed 20 years ago and have reached the end of their expected useful life. The

District will install a new cover and liner this fall to keep the reservoir in top condition and preserve our region's water reliability.

"The El Toro Regional Reservoir plays a crucial role in protecting our water supply," said District Engineering Manager Hannah Ford. "This \$24 million rehabilitation project will maintain water quality for decades."

At El Toro Water District, your water quality is our number one priority. We're proud to report that, as always, the drinking water we provide to our customers meets or exceeds all state and federal quality standards.

Our commitment to water quality runs deep, and we're dedicated to delivering safe drinking water to your home or business 365 days a year, 24 hours a day. In fact, District employees conduct more than 12,000 water quality tests every year from 70 representative sample locations throughout our service area. We also operate a



high-tech water quality laboratory that has the distinction of being one of only a few in Orange County certified by the California Environmental Laboratory Accreditation Program.

LEVEL 2 WATER SHORTAGE REDUCE YOUR WATER USE



The District is in a Level 2 Water Shortage. We are urgently asking customers to reduce their water use by 15% or as much as possible, fix leaks right away and continue to follow ETWD's Permanent Water Conservation Requirements that are in effect 365 days a year. Here's how you can do your part:



Take advantage of water-saver rebate programs

Save water and money with rebates for qualifying devices and upgrades. Here are just a few of the rebates available now.

- Turf removal: Earn up to \$4 per sq. ft. for residential and commercial customers.*
- **Toilet:** Earn up to \$100 per toilet to upgrade to a premium high efficiency toilet (four liter).*
- High Efficiency Clothes Washers: Earn up to \$200.*
- Drip irrigation: Earn up to \$0.50 sq. ft. up to 5,000 sq. ft.*
- Weather based smart sprinkler timer: Earn up to \$250.*

Small household leaks can add up to gallons of water lost every day, wasting precious water resources. Make sure to fix leaks, breaks or malfunctions in lines, fixtures or facilities as soon as possible.
