## YOU CAN PREVENT FOG CLOGS THIS THANKSGIVING

Keep the festivities flowing when you gather with family and friends this year by keeping **FOG (fats, oils and grease)** out of your drain. Holiday cooking, baking and parties mean that FOG is often present in the kitchen, but pouring it down the drain can lead to clogged pipes and sewer blockages. These messy clogs can cause sewer backups that can damage your home and the environment.

### What is FOG?

FOG refers to fats, oils and grease. Here are a few examples:



**Gravy**



**Sour cream**



**Meat drippings**



**Salad dressing and mayonnaise**



**Bacon grease**



**Butter, margarine, shortening and lard**



**Cooking oil**



### How Can I Properly Dispose of FOG and Keep My Pipes Clean this Season?



- **COOL IT:** After cooking, allow FOG to cool. Then, pour it into a container, such as an empty can or jar, and dispose of it in your green waste container or in the trash if you do not have organic recycling in your area.
- **SCRAPE IT:** Scrape FOG off pots and pans before washing, and wipe pans and dishes with a paper towel before washing to remove residual grease.
- **WATCH OUT FOR WIPES:** Kitchen and bathroom cleanup is an important part of hosting, but even wipes marked “disposable” are not safe for our sewer system. Toss cleaning wipes, personal wipes, baby wipes and any other wipe products directly in the trash. Do not flush them down the toilet. The only thing safe to flush are the three Ps – pee, poop and (toilet) paper.

# FROM THIRSTY TURF TO WATER-WISE WONDER: A CUSTOMER'S LANDSCAPE TRANSFORMATION



## A Success Story of Sustainability and Style

When Mr. and Mrs. Whitesell looked out at their lawn, they didn't just see grass—they saw an opportunity. With a vision of conservation and curb appeal, and support from ETWD staff, Metropolitan Water District of Southern California, the Municipal Water District of Orange County and the regional Water Use Efficiency Rebate Program, the Whitesells reinvented their landscape.



## Turning Vision Into Reality

Over the course of six months, the Whitesells worked with a local designer/installer to create a vibrant, climate-friendly landscape. First, they removed their water-thirsty lawn and installed a weed barrier of mesh material to help suppress regrowth and set the stage for the new design. Next, they installed water-wise plants and a drip irrigation system to deliver the right amount of water to each plant type based on its needs.

## A Diverse and Colorful Plant Palette

The new landscape features approximately 100 plants from 20 different species, selected for their low water use and vibrant aesthetic.

A sample of the plant palette includes:

- Penstemon
- Butterfly Bush
- Campanula
- Sedum Confusum
- Lavender Trumpet Vine
- Evolvulus 'Beach Bum Blue'
- Paprika Yarrow
- Mandevilla
- Bower Vine
- Crape Myrtle
- Agapanthus 'Baby Pete'
- Salvia 'Big Pink' (Autumn Sage)



These selections offer year-round color and habitat for pollinators and thrive in south Orange County's climate, reducing long-term maintenance needs.

## Design That Blends Beauty and Efficiency

The updated landscape includes flower beds bursting with seasonal blooms and a central area that utilizes bark mulch instead of turf—a creative and sustainable alternative that enhances visual texture and reduces runoff.

## Rebates at Work

ETWD's partnership in the regional Water Use Efficiency Rebate Program helped the Whitesells offset the cost of removing turf and installing water-smart features. The program empowers customers to make eco-friendly changes and celebrates their creativity.

This incentive provides \$100 per tree installed, with a maximum rebate of \$500 for up to 5 trees per turf replacement project. The Tree Rebate is not a standalone program. ## FLUORIDATION IN YOUR DRINKING WATER: WHAT YOU SHOULD KNOW



Protecting public health and delivering safe, high-quality drinking water remains ETWD's highest priority. Community water fluoridation began in the U.S. in 1945, and today, about 72% of Americans served by community water systems receive fluoridated drinking water.

### Fluoridation in California and Our Region

California law requires water systems with more than 10,000 service connections to fluoridate when funding is available. While ETWD does not independently add fluoride to the water, Metropolitan Water District of Southern California (MWDSC) where our water comes from does. MWDSC began fluoridation in 2007 after approval by the California Department of Public Health.

Naturally occurring fluoride in drinking water amounts to .3 -.4 mg/L. MWDSC adjusts this fluoride level to the recommended optimum level of 0.7 milligrams per liter (mg/L)—a concentration shown to provide dental health benefits while remaining far below both state and federal safety limits. For comparison:

- U.S. EPA primary limit: 4.0 mg/L
- California limit: 2.0 mg/L

### Safety and Scientific Review

This optimal U.S. level of 0.7 mg/L is well below both state and federal safety limits and is recognized as safe and effective by the U.S. Centers for Disease Control and Prevention (CDC) and the California Department of Public Health.

### Looking Ahead

While some states have moved to ban or reconsider fluoridation, the State of California continues to support the practice as a key tool for improving oral health.



### Our Commitment

ETWD is committed to delivering safe and reliable drinking water to our community. Your water continues to meet or surpasses all state and federal safety standards and we will continue to follow all state and federal regulations, monitoring any new water fluoridation developments and provide updates to our customers as needed.
